THE RESPONDENT POLICE.

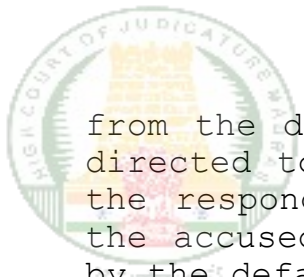
ORDER : The Court Made the following order :-

The petitioner, who apprehends arrest at the hands of the
respondent police for the offence punishable under Section 420 of
IPC in Crime.No.Not known of 2023, seek anticipatory bail.

2.Today, when the matter is taken up for hearing, the learned
Additional Public Prosecutor appearing for the respondent Police
submitted that petition enquiry is pending against the petitioner.

3.Heard the learned counsel for the petitioner and the learned
Additional Public Prosecutor for the respondent.

4. Considering the facts and circumstances, the respondent
police has to issue notice under Section 41(A) of Cr.P.C to the
petitioner and the petitioner is directed to appear before the
respondent police and the Investigating Officer has to conduct the
enquiry by strictly following the procedures therein and if any
prima facie case is made out against the petitioner, register the
F.I.R or close the petition enquiry within a period of two weeks



from the date of receipt of a copy of this order. The parties are directed to cooperate with the enquiry. It is needless to say that the respondent police shall not take any coercive steps to secure the accused till the completion of enquiry on the complaint lodged by the defacto complainant.
