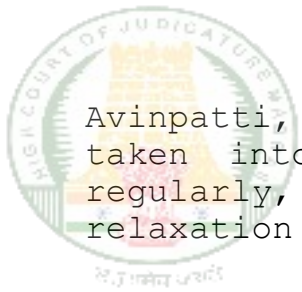
PRAYER IN CRL A(MD)No.314/2022:
