Prayer in CRL MP(MD) . No.1281 of 2023:-

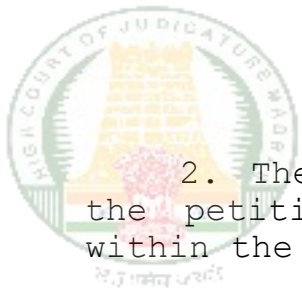
