The second respondent is directed to conduct an enquiry afresh after giving due notice to the petitioner and after affording opportunity of personal hearing to petitioner. The said exercise shall be done within a period of one month from the date of receipt of a copy of this order. No costs. Consequently, connected miscellaneous petition is closed.
