4.Considering the said submission, the condition imposed by this Court in Crl.O.P(MD).No.21638 of 2022, dated 07.12.2022 is modified to the effect that the petitioners 1, 2, 7 and 8 shall report before the respondent police once in a month, ie., on the first Saturday of every English Calendar Month at 10.30 a.m., until further orders; and the petitioners 3 to 6 shall report before the respondent police as and when required for interrogation on receipt of summons.

5.With the above direction, this Criminal Miscellaneous Petition is ordered.
