ORDER

2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2.

The learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2 would submit that the wife of the third respondent has given a complaint alleging job racketing and on the basis of the complaint, the parties were summoned and since the respondents therein including the petitioner had agreed to repay the amount, the complaint was ordered to be closed.

4. The learned counsel appearing for the petitioner would submit that the petitioner has already paid Rs.1,00,000/- to the third respondent
