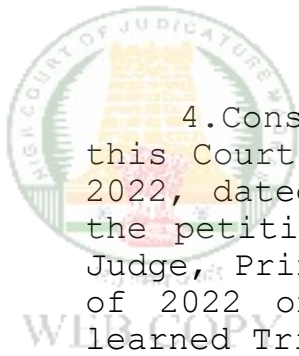

2.The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (Crl. Side) appearing for the respondent would submit that the final report has been filed and the case has been taken up for trial in C.C.No.17 of 2022 on the file the learned Additional District Judge, Principal Special Judge for NDPS Cases, Madurai and case stands posted on 01.02.2023.
