When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the State would submit that originally FIR was registered under Section 174(3) of Cr.P.C in Crime No.385 of 2022 and subsequently, altered into Section 302 IPC; that one Saroja was arrested and that the investigation is pending.
