### **ORDER**

After filing of the Writ Petition, the respondents have paid the salary for the month of November 2022, but failed to pay the salary for the month of December 2022.

3. Therefore, this Court is directing the respondents to consider the representation of the petitioner dated 12.12.2022 and pay the salary for the
