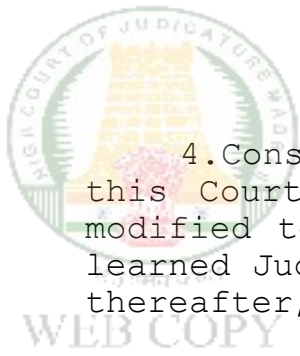

2.The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (Crl. Side) appearing for the respondent would submit that the petitioner has been complying with the condition regularly and investigation has been completed and charge sheet has already been filed before the learned Judicial Magistrate, Alangulam and the same is yet to be taken on file.
