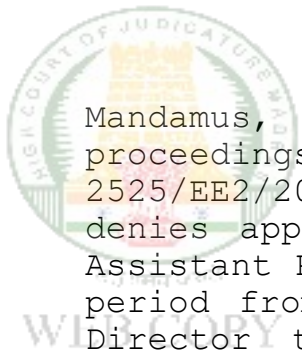

Mandamus, calling for the records relating to the proceedings issued by the 2nd respondent Joint Director Pa.Mu.O. 2525/EE2/2014 dated 30.04.2014 and quash the same in so far as it denies approval to the appointment of Rev. Sr. A.Nirmala Devi as Assistant Professor in Education in the petitioner's college for the period from 20.11.2013 to 04.02.2014 and further direct the Joint Director to give approval forthwith for the said period with continuity of service and all other attendant benefits.

ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.K.RAGATHEESH KUMAR, Advocate for M/S.ISAAC CHAMBERS, for the petitioner and of Mr.D.SADIQ RAJA, Additional Government Pleader on behalf of the Respondents, the court made the following order:-
