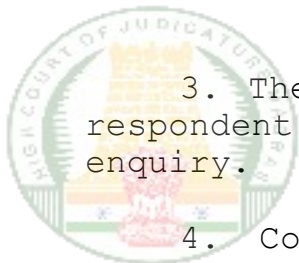
PETITION FOR BAIL Under Sec. 438 Cr.P.C.

PRAYER: FOR BAIL IN CRIME NO. NOT KNOWN OF 2023 ON THE FILE OF THE
RESPONDENT POLICE.

ORDER : The Court Made the following order :-

The petitioners, who apprehend arrest at the hands of the
respondent police for the alleged offences punishable under Sections
294(b), 406, 420 and 506(ii) of IPC in Crime No. Not known, seek
anticipatory bail.

2. Today, when the matter is taken up for hearing, the learned
Government Advocate(Crl.Side) appearing for the respondent Police
submitted that the petition enquiry is pending against the
petitioners in C.No. G5/3922599/41/TN/2523.



3. The learned Counsel for the petitioners submitted the respondent police is harassing the petitioners under the enquiry.

4. Considering the facts and circumstances, the respondent police is directed to conduct enquiry and if any *prima facie* case is made out against the petitioners, register the F.I.R or close the petition enquiry within a period of two weeks from today. The parties are directed to cooperate with the enquiry. It is needless to say that the respondent police shall not take any coercive steps to secure the accused till the completion of enquiry on the complaint lodged by the defacto complainant.

5. With the above directions, this Criminal Original Petition is disposed of. Consequently connected miscellaneous petition is closed.
