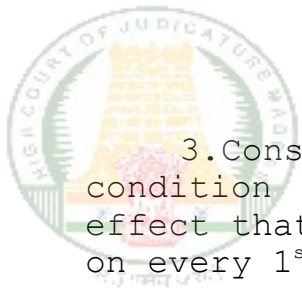
COMMON PRAYER IN CRL.MP (MD) .1663 & 1664/2023:
