3.The learned Government Advocate (Crl. Side) appearing for the respondent would submit that the petitioners have been complying with the conditions.



4.Considering the said submission, the condition imposed by this Court in Crl.M.P.(MD)No.15498 of 2022 in Crl.O.P(MD).No.19487 of 2022, dated 13.12.2022 is modified to the effect that the petitioners shall report before the respondent police as and when required for interrogation on receipt of summons.

5.With the above direction, this Criminal Miscellaneous Petition is ordered.
