Learned counsel appearing for the appellant submitted that the Writ Appeals may be dismissed giving liberty to the appellant to raise all the issues in the pending suit in O.S.No.504 of 2010, on the file of the II Additional Sub Court, Trichy.

2.Mr.R.Singaravelan, learned Senior Counsel appearing for the fourth respondent submitted that the Trial Court may be directed to dispose the suit uninfluenced by any of the observations made by the learned Single Judge in the impugned order and he has also requested to fix a time limit for disposal of the suit.
