PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records relating to impugned order passed by the first respondent, in his proceedings Na.Ka.No. 3020/A3/2019, dated 17.07.2020, quash the same as illegal, arbitrary and consequently, direct the second respondent to treat the Settlement Deed, dated 22.03.2012, in Doc.No.2738 of 2012 as fraudulent document and to make necessary entries in the appropriate register to enable the petitioners to proceed with further registration of the land in Survey Nos.6/1A1, 6/1A2, 6/1B, 6/1E, 6/1F2, 6/1G, 6/1H1, Thottanathu Village, Dindigul East Taluk, Dindigul District.
