4.Considering the said submission, the condition imposed by this Court in Crl.O.P(MD).No.21976 of 2022, dated 20.12.2022 is modified to the effect that the petitioners shall appear before the learned Judicial Magistrate No.I, Sivagangai on 20.02.2023 and thereafter, on the dates fixed by the learned Trial Judge.
