2.Today, when the matter is taken up for hearing, the learned Government Advocate(Crl. Side) appearing for the respondent police would submit that based upon the complaint given by the petitioner, enquiry was undertaken in C.S.R.No.100 of 2023. During the course of enquiry, it was found that it is a money dispute between the parties. During the course of enquiry, the parties appeared before the enquiry officer and they have given undertaking that they will settle the issue through the civil process. Based upon that undertaking, it was closed.
