2.The learned counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for modification of the condition.

3.The learned Government Advocate (Crl. Side) appearing for the respondent would submit that the petitioners have been complying with the conditions regularly and investigation has been completed and the charge sheet has already been filed before the learned



Judicial Magistrate, Tenkasi and the same is yet to be on file.

Considering the said submission, the condition imposed by this Court in Crl.O.P(MD).No15015 of 2022, dated 09.11.2022 is modified to the effect that the petitioners shall report before the learned Judicial Magistrate, Tenkasi on 01.03.2023 at 10.30 a.m and thereafter, on the date fixed by the learned Trial Judge.

5. This Criminal Miscellaneous Petition is ordered accordingly.
