PRAAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records on the file of the 2nd respondent in connection with the impugned order passed by him in his proceedings in Na.Ka.No.8897/Aa2/2022 dated 06.01.2023 and quash the same as illegal and arbitrary and consequently directing the second respondent to conduct De Nova enquiry after affording opportunity to the petitioner to cancel the sale deeds registered on the file of 3rd respondent in Doc.Nos.8242/2022, 8244/2022, 8245/2022, 8246/2022, 8247/2022, 8248/2022, 8249/2022 and 8250/2022 dated 21.07.2022 executed by the 5th respondent in favour of respondents 6 to 12 within a time limit that may be stipulated by this Court.
