ORDER

The above writ petition has been filed for the issue of a Writ of Mandamus considering the petitioner's representation dated 08.01.2020 to remove or shift the alignment of overhead electric line passing over the patta land comprised in S.Nos.359/3A and 359/3B at Kampiliyampatti Village, Dindigul Taluk.

2.When the matter had come up, the learned Standing Counsel for the respondents has produced a letter dated 03.02.2020 issued by the third respondent to the petitioner rejecting the request for shifting the overhead electric line stating that if there is any dispute, the parties could work out their remedy before the civil Court.
