Prayer:Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the first respondent herein to revoke the suspension order dated 08.08.2022 and consequently reinstate the petitioners into service as Salesman in TASMAC Shop No. 7014 on the basis of the proposal sent by the 2nd respondent vide Na.Ka.No.A1/0743/2022 dated 20.10.2022.

ORDER

This writ petition has been filed for a direction to the first respondent herein to revoke the suspension order dated 08.08.2022 and consequently reinstate the petitioners into service as Salesman in TASMACH Shop No.7014 on the basis of the proposal sent by the 2nd respondent vide Na.Ka.No.A1/0743/2022 dated 20.10.2022.

2. The case of the petitioners is that the petitioners and other co-employees have committed illegal activities while they were in duty and they were placed under suspension on 08.08.2022. The suspension of the petitioners has not been revoked. However, the suspension of the similarly situated person was revoked. Hence, the petitioners have made representation to revoke the suspension order on 02.12.2022. However, the same has not been considered. Therefore, the petitioners have filed the present writ petition with the aforesaid prayer.

3. The learned counsel appearing for the petitioners would submit that it would suffice, if the first respondent is directed to dispose of the representation of the petitioners, dated 02.12.2022, on merits and in accordance with law, within a specified period.

4. The learned counsel appearing for the respondents has no serious objection for such an order being passed by this Court.

5. Considering the limited request made by the learned counsel for the petitioners, this Court, without going into the merits of the matter, directs the first respondent to consider the representation of the petitioners, dated 02.12.2022 and pass appropriate orders, on merits and in accordance with law, within a period of twelve weeks from the date of receipt of a copy of this order.
