Prayer in CRL MP(MD) . 9504/ 2022 :

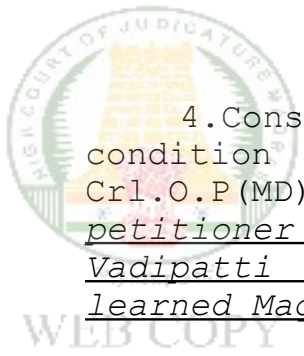
