ORDER

He would further submit that summons has not been issued so far.

3. Recording the submission made by the learned Government Advocate (Criminal Side), the concerned Tahsildar, if inclined to take further proceedings, is directed to issue summons to the petitioner and on receipt of the summons, the petitioner is directed to appear before them.
