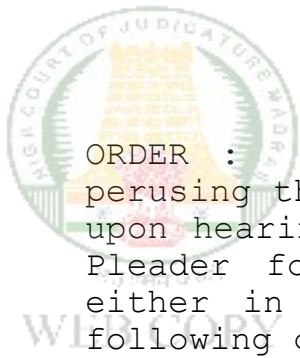
PRAYER IN WA(MD) No.SR17878 of 2019:
