Prayer in CRL MP(MD)No. 2204/ 2023 :

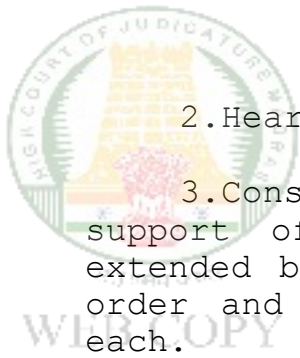
