Prayer in CRL MP(MD). 2231/ 2023 in CRL OP(MD)No.21999 of 2022:

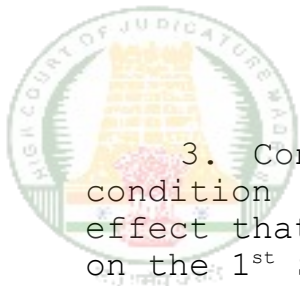
To relax the conditions imposed by this court in Crl O.P (MD) No. 21999 of 2022 dated 13.12.2022.
