2. Admittedly, the petitioner is the wife of the fourth respondent.

3.The learned counsel for the petitioner would submit that there existed property dispute between the petitioner and the private respondents, due to which, the respondents 4 to 6 are harassing the petitioner and threatened her with dire consequences. Hence, she lodged the complaint.

4. It is evident from the records that there existed civil dispute between the parties.
