Prayer:- Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Certiorarified mandamus to call for the records pertaining to the impugned selected candidates result in Direct Recruitment for the post of Village Assistant dated 28.01.2023 passed by the 4th respondent herein and quash the same and to direct the respondent to appoint the petitioner for the post of Village Assistant.

ORDER

The petitioner has filed this writ petition challenging the impugned selection of the candidates for the post of village assistant dated 28.01.2023 and for a direction to the respondents to appoint the petitioner.

2.The learned counsel for the petitioner would submit that though the petitioner has filed this writ petition challenging the appointment of the candidates as village assistants in Narasingampatti village, the learned counsel restricted his prayer to the effect that a direction may be issued to the respondents to furnish the list of selected candidates along with the details of counselling ratio and marks obtained by them.
