Recording the submissions made by the learned counsel for the petitioner and the learned Additional Public Prosecutor, the writ petitioner is directed to give fresh representation and on receipt of the same, the second respondent is directed to conduct enquiry and issue Non-traceable Certificate to the writ petitioner, after ensuring the said
