made in Crl.OP(MD)No.16719/2022, on the file of this Court.

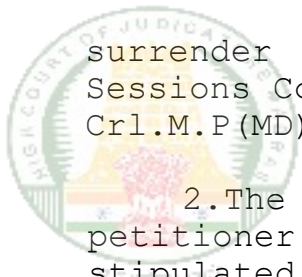
Prayer in CRL OP(MD).No. 16719 of 2022:
