2. When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the State would submit that the prosecution has filed the additional charge sheet on 14.02.2023, altering the cases from 306 IPC to 294(b) and 304(B) IPC.

3. The learned counsel for the petitioners would submit that the liberty may be given to the petitioners to challenge the charge sheet.
