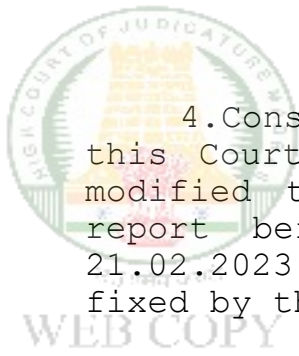

This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.22032 of 2022, dated 14.12.2022.

2.The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (Crl.
