PETITION FOR BAIL Under Sec.439 of Cr.P.C.

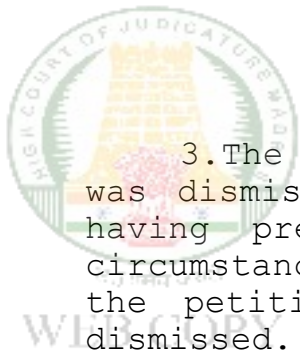
PRAYER :-

Hence, this Court is not inclined to grant bail to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
