Writ Miscellaneous Petition is filed under Article 226 of the Constitution of India, praying this Court to extend the time for paying the 3rd instalment as directed by this Court vide its final order dated 14.11.2022 in WP(MD) 11340/2022.

Prayer in WP(MD) . 11340/ 2022 :

Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Certiorari, calling for the records culminating into the Notice dated 20.05.2022 in Na.Ka.No. 831/2020/E passed by the 2nd respondent based on the order dated 18.12.2020 in ROC.No. 35151/2018/C5 by the 1st Respondent u/s. 14 of the Securitisation and Reconstruction of Financial assets and enforcement of Security Interest Act (SARFAESI Act) and set aside the same as illegal.

ORDER:- This Petition coming on for hearing on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.G.Vishnuram, Advocate for the Petitioner, this Court made the following order:

But we are inclined to grant a further period of two weeks for payment of the third instalment.
