COMMON ORDER

The Management filed the writ petitions in W.P.(MD).No.5751 of 2019 and 28924 of 2022, for issuance of a writ of Mandamus, directing the official respondents to pay the maintenance grant at 75% by calculating 75% of the salary payable to the approved non-teaching staff working in the approved and sanctioned post from the date of appointment with all benefits and emoluments as per the order of approval including pension in accordance with the order passed by this Court in W.P.No.4517 of 2006 dated 19.06.2006 and the Government letter dated 31.05.2016. Similarly, the employees of the Management have also sought the very same prayer in W.P.(MD)Nos.8083 and 8138 of 2021 and W.P.(MD).No.2782 of 2023.

2. Since the issue involved in these writ petitions is one and the same, they have been taken up together and disposed of by this common order.
