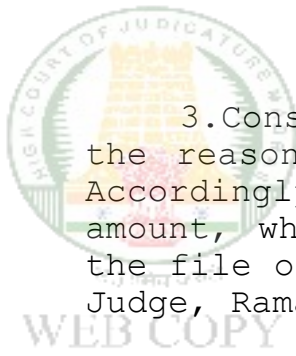
Prayer in CMA(MD). 48/ 2020 :
