The prayer in this Writ Petition is seeking for issuance of a Writ of Mandamus, directing the respondents 1 and 2 to cancel the patta and remove the encroachment in respect of the property comprised in Survey No.447/5 made by the fourth and fifth respondents, based on the petitioner's representation, dated 30.01.2023.

Today, when the matter is taken up for hearing, the learned Government Pleader appearing for the respondents 1 to 3 has produced the communication of the second respondent in Na.Ka.No.A3/6039/2022, dated 03.02.2023 and submitted that patta granted in favour of the respondents 4 and 5 has been cancelled.
