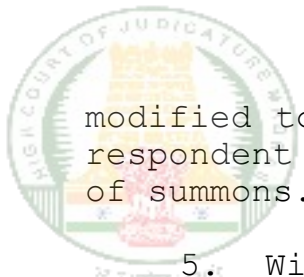

2. The learned counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3. The learned Government Advocate (Crl. Side) appearing for the respondent would submit that the petitioners have been complying with the conditions.

4. Considering the said submissions and nature of offence, the condition imposed by this Court in Crl.O.P(MD).No.1355 of 2023, is
