When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents would submit that there is no threat to the life of the petitioner and the dispute arose between the petitioner and one Kathiravan that they are over the parking the vehicle in front of the party office, because of the parking of the vehicle, they are not in a position to function in the above said premises.
