ORDER : The Court made the following order :-

The petitioner, apprehends arrest at the hands of the respondent police for the offences punishable under Sections 420 of I.P.C r/w 66D of Information Act in crime No.2 of 2022, seeks anticipatory bail.

The learned Government Advocate (criminal side) submitted that this is the second application filed by the petitioner and earlier, the petitioner filed Crl.O.P.(MD) No.22176 of 2022, wherein, this Court dismissed the petition. Therefore, there is no change of circumstance and hence, he opposed for granting anticipatory bail to the petitioner.

5. Taking note of the facts and circumstances, since there is no change of circumstances, this Court is not inclined to grant anticipatory bail to the petitioner.

6. Accordingly, this criminal original petition is dismissed.
