2.The learned counsel for the petitioner would submit that in the anticipatory bail petition, he had mentioned the accused rank as Single Accused, instead of mentioning as '**Rank not known**' and the satisfaction Court as Judicial Magistrate, Tenkasi instead of mentioning as '**Judicial Magistrate, Ambasamudram**'.

3.Considering the reason stated by the petitioner, this petition is allowed. Registry is directed to amend the order and issue a fresh copy, to the parties concerned and time is also extended further for a period of two weeks, from the date on which
