Prayer in CRL MP(MD). No.3053 of 2023:-

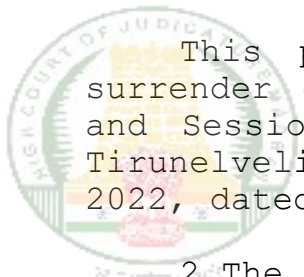
