This Writ Petition has been filed seeking a Writ of Mandamus, to direct the respondents herein to grant permission and to provide police protection to conduct the district level “ Kabadi Tournament” on 25.02.2023 and 26.02.2023 at Varatharajarkoil ground, Seithunganallur Village, Thoothukudi District by considering the petitioner's representation, dated 14.02.2023.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting tournament. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner, dated 14.02.2023 and pass suitable orders by fixing the time for tournament, based on the above said circular.
