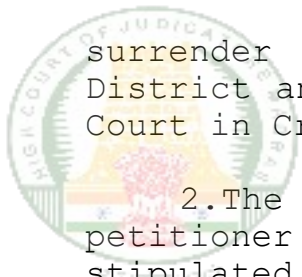
Prayer in CRL OP(MD). 376/ 2023 :
