Prayer in REV.APLC.SR(MD) .62213/2021:

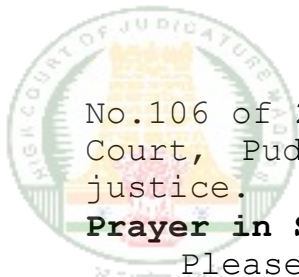
