2. The learned Government Advocate (Criminal Side) would submit that on the basis of the direction issued by the learned Judicial Magistrate No.I, Trichy in Cr.M.P.No.352 of 2022, enquiry was undertaken, during the course of enquiry, both parties appeared and there was a settlement entered between them by which, the accused person gave a sum of Rs. 3,00,000/- to the petitioner/complainant.
