**Prayer:** Writ Petition is filed under Article 226 of the Constitution of India praying for issuance of a Writ of Certiorarified Mandamus, calling for the entire records relating to the impugned proceedings issued by the 2<sup>nd</sup> respondent, dated 23-12-2020 in Na.Ka.No.36/2020/A3 and quash the same and consequently direct the respondents either to extend the period of lease of right in respect of collecting charges for visitors using the Courtallam Bus Stand shopping complex Shop No.1 of Courtallam, Tenkasi District, till 31-03-2022, or to refund the entire bid amount paid by the petitioner to the 2<sup>nd</sup> respondent of a sum of Rs.47,665/-.
