ORDER

This Criminal Original Petition has been filed, invoking Section 482 Cr.P.C., seeking direction to the second respondent to provide adequate protection to the petitioner's life and limb and her family members based on the petitioner's representation dated 09.02.2023.

When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2 would submit that civil suit decree is standing in favour of the petitioner and on that basis, the representation was made by the petitioner. The respondent police received the petitioner's representation only on 10.02.2023 and the same is pending for consideration.
