COMMON PRAYER :-

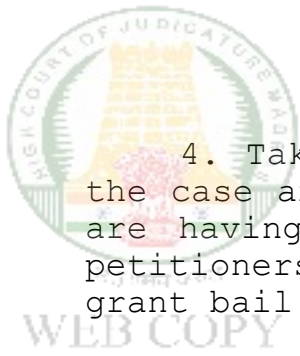
For Bail in Crime No. 999 of 2022 on the file of the respondent police.
